RESOLUTION OF THE ALABAMA REPUBLICAN PARTY EXECUTIVE COMMITTEE
SUPPORTING DIGNITY AND NON-DISCRIMINATION IN THE STATE OF ALABAMA

WHEREAS the Alabama Republican Party Executive Committee encourages all individuals associated with Alabama to respect the dignity of others; not to discriminate against others based on race; to acknowledge the right to express differing opinions, foster, and defend intellectual honesty; to engage in freedom of inquiry and instruction; and to honor freedom of speech and association; and

WHEREAS concepts that assign fault, blame, a tendency to oppress others, or the need to feel guilt or anguish because of race, violate the premises of individual rights, equal opportunity, and individual merit and undermine our constitutional republic, free-enterprise system, and our democratic way of life; and

WHEREAS these concepts promote discord and impede Alabama citizens from reaching their full potential, divide Americans and Alabamians, and perpetuate discrimination; and

WHEREAS the Alabama Board of Education passed a resolution saying they will not support any K-12 public education resources or standards intended to indoctrinate students in social or political ideologies that promote one race or sex above another; and

WHEREAS we reject the belief that the United States of America is an inherently racist country or that Alabama is an inherently racist state.

THEREFORE, BE IT RESOLVED, that the Alabama Republican Party Executive Committee urges Alabama's state legislative and executive branches to enact and implement strong laws during the 2022 legislative session that strengthen the dignity of individuals and prohibit propagation of divisive concepts in public schools and in the workplace.


BE IT FURTHER RESOLVED, that this legislation should prohibit any employee or independent contractor of a state agency or public school from teaching, or requiring any state employee, state contractor, or teacher to make use of, instructional materials or practices that attempt to indoctrinate students or employee in these divisive concepts.

BE IT FURTHER RESOLVED, that this legislation should prohibit public schools and state agencies from requiring course credit or other work for advocating these social and public policies.


BE IT FURTHER RESOLVED, that private or federal funding should not be accepted to develop curriculum, purchase course materials, provide training, or sponsor activities that support these divisive concepts, and that federal funding which requires teaching these concepts or implementation of any practices contrary to this Resolution shall neither be applied for by the State of Alabama nor accepted.

BE IT FURTHER RESOLVED, that legislation should require publication and public access of all curriculum and/or training materials for teachers and/or students prior to the use of such training materials or curriculum.

RESOLUTION CALLING FOR GUARDIANSHIP/CONSERVATORSHIP REFORM IN ALABAMA

WHEREAS over 1.5 million Americans are under the care of guardians/conservators who control nearly \$300 billion in assets; and

WHEREAS many guardians are dedicated and caring individuals who play an important role in protecting vulnerable citizens; however, unscrupulous guardians, attorneys, and doctors are able to exploit the lack of oversight in the current system in order to claim absolute control of life, liberty, and property of their wards; and

WHEREAS once an individual is made a ward of the state, they lose all rights involving self-determination, including the right to enter into a contract (including the right to choose an attorney), control assets and make financial decisions, choose where to live, accept or refuse medical treatment, and vote; and

WHEREAS once a guardianship is imposed, there are often few safeguards to protect against individuals who choose to abuse the system making it extremely difficult for an individual who regains capacity or was wrongly placed under a guardianship/conservatorship to have their rights fully restored; and


WHEREAS a number of high-profile cases throughout the country and within our state have brought enormous attention to our broken guardianship/conservatorship system which has made the public aware of the potential for abuse.

THEREFORE, BE IT RESOLVED that the Alabama Republican Party Executive Committee urges each Republican member of the Alabama Legislature to promptly enact legislation to reform Alabama's broken guardianship/conservatorship system.



RESOLUTION DEFENDING UNA SGA PRESIDENT JAKE STATOM

WHEREAS Jake Statom, an engineering major from Tuscumbia, was elected president of the University of North Alabama Student Government Association (“SGA”) in February, 2021; and,

WHEREAS Statom reposted an Instagram post about the “LGBTQ” agenda and added a statement that sought to promote traditional morals and biblical values; and,

WHEREAS some students responded to Statom’s comment, which was made on his personal social media account, with a petition demanding his resignation from the SGA presidency by June 30, 2021, and threatening impeachment proceedings if he did not concede to their demands; and,

WHEREAS Statom released a video statement apologizing to those who might have been hurt by his online comment and committed to being more thoughtful and considerate of differing perspectives; and,

WHEREAS a student-led counter petition supporting Statom’s right to free speech and expression garnered more signatures than the one that issued threats of political reprisals; and,

WHEREAS the university environment is traditionally one which promotes the free and open exchange of ideas - both conservative and liberal - and protects an individual’s right to their own religious beliefs, values, and moral standards; and,

WHEREAS the dangerous “Cancel Culture” atmosphere that predominates on college campuses both in Alabama and across the country seeks to silence opinions that are deemed to be politically unacceptable to leftist ideologues and punish those who continue to adhere to traditional values, especially those rooted in fundamental religious teachings; and,

WHEREAS Statom committed no impeachable offense by simply exercising the basic freedoms of opinion, expression, and religion that are guaranteed to all Americans under the Bill of Rights of the U.S. Constitution; and,

WHEREAS the Governor Kay Ivey signed HB498, sponsored by Representative Matt Fridy, into law in 2019, which included language emphasizing, “freedom of expression is critically important during the education experience of students, and [that] each public institution of higher education should ensure free, robust, and uninhibited debate and deliberation for students.”

THEREFORE, BE IT RESOLVED that we, the members of the Alabama Republican Party, support Jake Statom’s right to express and promote his personal beliefs in the public square and recognize his voluntary willingness to apologize to those he may have offended; and,

BE IT FURTHER RESOLVED that we strongly oppose any effort to impeach, remove, or apply

political pressure from students or members of the faculty and staff intended to force Jake Statom from the presidency of the University of North Alabama SGA.

WHEREAS, Mr. May has served on the Alabama State Executive Committee and the Alabama Republican Party State Steering Committee; and




WHEREAS, he is a member of the American Legion and Veteran of Foreign Wars Member;

WHEREAS Big Tech and their owners have no right to decide what Alabamians read and hear, and must allow differing viewpoints to be expressed on their platforms; and


WHEREAS Technology giants have put the country at a point where a handful of Big Tech companies and their owners who control the modern information superhighway are engaging in censorship and the shutdown of free speech and the exchange of ideas contrary to their beliefs; and

WHEREAS Florida has enacted a law that will protect citizens from Big Tech's "power grab on speech, thought, and content," and allow Floridians to fight back against de-platforming and censorship by allowing them to sue for \$100,000 in damages for each proven claim; and


WHEREAS this law also requires companies to detail how they reach conclusions about content moderation and requires companies to equally apply these standards under penalty of law to be enforced by the Florida Attorney General.

RESOLUTION REGARDING VOTING INTEGRITY

WHEREAS it is every American citizens' right to vote if they are legally registered to vote; and

WHEREAS there have been several instances where the security and integrity of elections have come into question nationally; and

WHEREAS the Alabama Legislature has taken steps to strengthen and protect voting laws in Alabama; and

WHEREAS it is important to continue to strengthen the integrity of the voting process in Alabama.

THEREFORE, BE IT RESOLVED, that the Alabama Republican Party Executive Committee requests that the Alabama Legislature draft and pass legislation that will strengthen the penalties of those who illegally harvest ballots;

BE IT FURTHER RESOLVED, that the Alabama Legislature draft and pass legislation that will allow greater oversight over the absentee ballot process from start to finish;

BE IT FURTHER RESOLVED, that the Alabama Legislature draft and pass legislation that will ensure that any election officials (e.g., Probate Judge, Sheriff, Circuit Clerk) recuse themselves from the election process if they are opposed or any of their immediate family are opposed on a ballot which they oversee;



BE IT FURTHER RESOLVED, that the Alabama Legislature pass no laws that will allow no excuse absentee ballot voting;


BE IT FURTHER RESOLVED, that the Alabama Legislature pass no laws that will restrict the ability of lawful poll watchers from observing the process;

DECLARATION THAT ALABAMA IS A SANCTUARY STATE FOR THE UNBORN

WHEREAS, every child is a person, from the moment of conception, and endowed by their Creator with certain inalienable rights: among them are life, liberty, and the pursuit of happiness.

WHEREAS, under Alabama Law, unborn children are persons who possess the fundamental right to life.¹

WHEREAS, it is a core function of Government to protect the innocent from oppression by the strong.

WHEREAS, it is the public policy of the State of Alabama, engrafted into the Constitution of Alabama by Amendment 930, “to ensure the protection of the rights of the unborn child in all manners and measures lawful and appropriate.”

WHEREAS, under the Tenth Amendment of the U. S. Constitution, states have the power to recognize the personhood of unborn children within their territorial jurisdictions.

WHEREAS, *Roe v. Wade* and its progeny do not prevent states from exercising their authority under the Tenth Amendment to legally recognize unborn children as persons who possess the right to life under the laws of their respective states.

WHEREAS, there are currently five abortion clinics within the State of Alabama that regularly destroy unborn babies: Alabama Women’s Center, Huntsville; Reproductive Health Services, Montgomery; West Alabama Women’s Center, Tuscaloosa; Planned Parenthood, Mobile; and Planned Parenthood, Birmingham.

WHEREAS, approximately 6,009 unborn children each year are killed by abortion providers across the state.

WHEREAS, the Alabama Constitution, Statutes (including The Alabama Human Life Protection Act), and Case Law confer authority to protect unborn children's right to life on the Governor, the Attorney General, and the District Attorneys.


WHEREAS, the Governor, the Attorney General, and District Attorneys of the State of Alabama are obligated by la to enforce the constitutional right to life of the State's unborn children.

THEREFORE, BE IT RESOLVED, that the Alabama Republican Party, acting by and through its State Executive Committee duly assembled, expresses its strong support for the Governor, the Attorney General, and respective District Attorneys of the State of Alabama to do all in their power to protect the sanctity of the life of the unborn, including but not limited to, the immediate closure of all abortion clinics in Alabama.



RESOLUTION SUPPORTING PREVENTION OF COVID-19
VACCINATION OF 0-18 YEAR OLDS

WHEREAS, children are our most valuable resource; and

WHEREAS, children and teens have much lower risk of getting seriously ill with (and spreading) or dying from COVID-19 for those less than 17 years of age is less than 1 in 100,000; and

WHEREAS, the risk of dying or being permanently disabled from the COVID-19 vaccines for individuals under 17 years of age is 14 to 20 times greater than the risk from the COVID-19 infection itself; and

WHEREAS, Dr. Robert Malone, the inventor of the mRNA technology (used in COVID vaccine) has declared that neither young adults nor teens should be forced to take it. Risk-benefit analysis is lacking for this age group, thus making COVID-19 vaccines too risky for a youthful population that is not otherwise at risk; and

WHEREAS, there have been a disproportionate number of cases of myocarditis / pericarditis for young males as reported to VAERS (Vaccine Adverse Event Reporting System). The number could be higher as VAERS' data collection is optional and time consuming; and


WHEREAS, some data suggests that the vaccines are ineffective against the COVID-19 variants, which limits their benefits; and

WHEREAS, the Nuremburg Code prevents human medical experimentation. Congress, however, with the understanding that we were facing a global pandemic, granted immunity to vaccine manufacturers without trials first. This allowed for administering their product to adults with the suggestion that those immune compromised receive treatment first; and


WHEREAS, the Hippocratic Oath dictates physicians to “do no harm”,

THEREFORE, BE IT RESOLVED, that the vaccination of children (minors) should not be mandated in the State of Alabama. Parents, however, should have medical freedom of choice.
